Cookies Policy

1. Introduction

This cookies policy (the “**Policy**”) explains how Stonefort Securities LLC (referred to interchangeably herein as “**Stonefort Securities**” or “**we**” or “**our**” or “**us**”) uses cookies and similar technologies when users visit our website.

Stonefort Securities holds a Category 5 License (No. 20200000226) issued by the United Arab Emirates’ Capital Market Authority, through which it is authorized to conduct financial consultation, promotion, and introduction activities. In line with its license, Stonefort Securities may introduce clients to trading services and financial products provided by Stonefort Securities Limited, which holds a full-service dealer (excluding underwriting) license (license No. GB 24202921) issued by the Mauritius Financial Services Commission (referred to herein as “**SFS**”).

The Policy applies only to the use of cookies on the Stonefort Securities website and does not apply to external websites that may be accessed through links on our platform.

2. What Are Cookies?

Cookies are small text files stored on a user’s device such as a computer, tablet, or smartphone when visiting a website. Cookies help websites function efficiently and improve the user experience by remembering preferences and collecting anonymous usage data. Cookies can either be session-based (deleted once you close your browser) or persistent (stored on your device until they expire or are manually deleted). Cookies may be set by the website you are visiting (first-party cookies) or by third-party services used by that website (third-party cookies).

3. How We Use Cookies

Stonefort Securities uses cookies for several purposes, including:

- (A) Ensuring the proper functioning of our website.
- (B) Remembering user preferences and settings.
- (C) Analysing website traffic and performance.
- (D) Improving the usability and functionality of our services.
- (E) Supporting marketing and website optimisation activities.

Cookies used on our website do not store sensitive personal information such as banking or trading account credentials.

4. Types of Cookies We Use

Strictly Necessary Cookies

These cookies are essential for the operation of our website. They enable core functionality such as navigation, security, and session management. Disabling these cookies may affect how the website functions.

Performance and Analytics Cookies

These cookies collect anonymous information about how visitors use our website, such as pages visited and traffic patterns. This helps us improve the website and user experience.

Functional Cookies

These cookies remember user preferences such as language or region settings to provide a more personalised experience.

Third-Party Cookies

Some cookies may be placed by trusted third-party services used by Stonefort Securities, such as analytics or marketing platforms. These providers may collect usage information in accordance with their own privacy policies.

5. Managing Cookies

Users can control or disable cookies through the settings of their internet browser. Most browsers allow users to:

- (A) Block all cookies.
- (B) Allow only first-party cookies.
- (C) Delete existing cookies.

Please note that disabling cookies may affect certain features and functionality of the website.

6. Amendments to the Policy

Stonefort Securities may amend the Policy from time to time, at its sole discretion. Any amended version shall become effective on the date that the amended version of the Policy is posted on our website, or, if we elect to deliver a notice to you, on the date displayed in the notice. If no date is specified in the notice, the amended Policy shall become effective immediately upon publication. By continuing to use our services after such publication or notice, you are deemed to have accepted and agreed to the amended Policy.
